FIRST LIEN TERM LOAN TRADEMARK SECURITY AGREEMENT RELEASE

This FIRST LIEN TERM LOAN TRADEMARK SECURITY AGREEMENT RELEASE (the “*Release*”) dated June 20, 2019, is made by Morgan Stanley Senior Funding, Inc. (“*MSSF*”), as collateral agent (in such capacity, and as further defined in Section 1.01 of the First Lien Term Loan Guarantee and Collateral Agreement, dated as of November 15, 2012, the “*Collateral Agent*”) for the Secured Parties in favor of Smart & Final Stores LLC, a California limited liability company (“*S&F*”), and Cash & Carry Stores LLC, an Oregon limited liability company (together with S&F, the “*Grantors*”). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Credit Agreement.

WHEREAS, the Grantors entered into that certain First Lien Term Loan Credit Agreement, dated as of November 15, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time prior to the date hereof, the “*Credit Agreement*”) among SF CC Intermediate Holdings, Inc., a Delaware corporation, S&F, as borrower, the Lenders from time to time party thereto and MSSF, as administrative agent and as collateral agent;

WHEREAS, pursuant to the Credit Agreement, the Collateral Agreement (as defined in the Credit Agreement) and that certain First Lien Term Loan Trademark Security Agreement between the Collateral Agent and the Grantors, dated as of November 15, 2012 (as amended, amended and restated, supplemented, or otherwise modified from time to time prior to the date hereof, the “*Trademark Security Agreement*”), the Grantors granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to certain intellectual property of the Grantors;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 7, 2012 at Reel 4914 and Frame 0047; and

WHEREAS, in accordance with the provisions of the Credit Agreement and the Trademark Security Agreement, the indebtedness and all other Obligations owing under the Credit Agreement have been paid in full, and the Collateral Agent now agrees to release its security interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby releases to the Grantors its security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral listed on Schedule I hereto granted pursuant to the Trademark Security Agreement.


SECTION 2. Recordation; Further Assurances. The Collateral Agent hereby authorizes the Grantors or the Grantors’ authorized representative, at the Grantors’ sole cost and expense, to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release of the security interest of the Collateral Agent in the Trademark Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. The

Collateral Agent further agrees to execute and deliver to the Grantors any and all further documents and instruments, and do any and all further acts, which the Grantors (or their agents or designees) reasonably request, at the Grantors' sole cost and expense, necessary to effectuate this Release and the Grantors' right, title and interest in, to and under the Trademark Collateral.

SECTION 3. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
