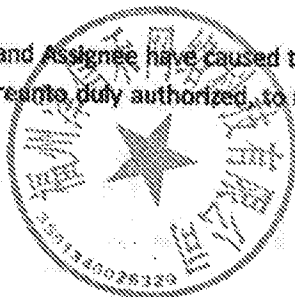
WHEREAS, Assignee is desirous of acquiring the Marks, together with the Goodwill and the Applications and Registrations and all other IP;

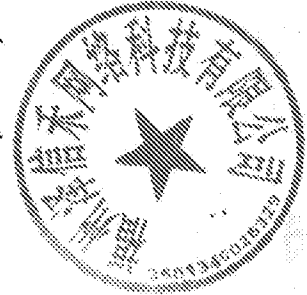
