## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”) is made as of November 22, 2017, by **BREGAL INVESTMENTS, INC.**, in its capacity as Investor Representative (“**Secured Party**”), in favor of **YAPSTONE HOLDINGS, INC. (f/k/a Yapstone, Inc.)**, a Delaware corporation (“**Debtor**”).


**WHEREAS**, pursuant to that certain Note Purchase Agreement (as supplemented or otherwise modified from time to time), dated as of February 27, 2015, executed by Debtor in favor of Secured Party and that certain Intellectual Property Security Agreement (Trademark) (the “**Trademark Security Agreement**”), dated as of February 27, 2015, executed by Debtor in favor of Secured Party, and recorded in the records of the United States Patent and Trademark Office on March 2, 2015 at Reel/Frame 5468/0831, Debtor granted to Secured Party a continuing security interest in all of Debtor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including those trademarks set forth on Schedule 1.1 hereto.


**FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and adequacy of which are hereby acknowledged, Secured Party hereby (a) terminates and releases all liens and security interests granted by Debtor in favor of Secured Party in the Trademark Collateral and (b) assigns, transfers and delivers to Debtor all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof. Secured Party hereby authorizes Debtor or its designee to make filings with the United States Patent and Trademark Office and take further actions necessary to evidence the release and termination of Secured Party’s security interests in the Trademark Collateral. The Secured Party hereby authorizes the governing body of the United States Patent and Trademark Office to record this Release.
