## ASSIGNMENT OF TRADEMARK RIGHTS

Assignor hereby authorizes any official of any country empowered to issue trademarks to record this Assignment, and to issue or transfer the Marks to the Assignee as owner of all right,


title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.


