INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment"), dated March 20, 2019, is by Open Labs, LLC, a Texas limited liability company ("Seller"), in favor of Roland Corporation, a Japanese corporation ("Buyer").

RECITALS

1. Pursuant and subject to the terms of the Purchase Agreement, Seller hereby sells, transfers, assigns, conveys, and delivers to Buyer, its successors and assigns, forever, all of Seller's rights, title and interests, legal or equitable, in and to all of the Purchased Trademarks.
2. Seller hereby warrants, covenants and agrees that, from time to time after the delivery of this instrument, at the Buyer's request and without further consideration, it will do, execute, acknowledge and deliver, or will cause to be done, executed, acknowledged and delivered, all and every such further acts, deeds, conveyance, transfers, assignments, powers of attorney and assurances as reasonably may be required to more effectively convey, transfer to and vest in Buyer, and to put Buyer in possession of any of the Purchased Trademarks.
3. Nothing in this Assignment, express or implied, is intended or shall be construed to expand or limit in any way the representations, warranties, covenants, rights, obligations, claims or remedies of the parties as set forth in the Purchase Agreement.
4. This Assignment inures to the benefit of and is binding upon the Buyer and the Seller and their respective successors and assigns.

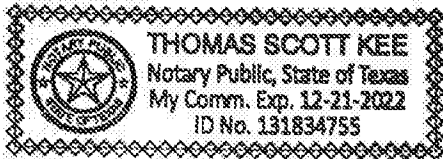
