RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of June 19, 2019 (this “**Trademark Security Release**”), by BANK OF AMERICA, N.A., as Collateral Agent (the “**Agent**”), in favor of Yankees Entertainment and Sports Network, LLC, a Delaware limited liability company (the “**Grantor**”). Reference is made to (a) that certain Security Agreement, dated as of December 15, 2017 (as amended, modified, restated or supplemented from time to time, the “**Security Agreement**”; capitalized terms used but not defined herein have the meanings defined in the Security Agreement), among the Grantor and the Agent and (b) that certain Notice of Grant of Security Interest in Trademarks, dated as of December 15, 2017 (the “**Notice**”), between the Grantor and the Agent (together with the Security Agreement and the Notice, the “**Security Documents**”).

WHEREAS, pursuant to the terms and conditions of the Security Documents, the Grantor granted to the Agent a security interest in and to all of the Grantor’s right, title and interest in, to and under the Trademark set forth on Schedule I (the “**Released Trademark Collateral**”).

WHEREAS, the Notice in the Released Trademark Collateral was recorded with the United States Patent & Trademark Office (the “**USPTO**”) on December 18, 2017 at Reel/Frame 6230/0935.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent and the Grantor hereby agree as follows:

SECTION 1. Release of Security Interest. The Agent does hereby release to the Grantor, without recourse, representation or warranty of any kind, Agent’s security interest granted pursuant to the Security Documents in and to the Grantor’s right, title and interest in and to the Released Trademark Collateral identified in Schedule I attached hereto.


SECTION 2. Governing Law. This Trademark Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.

SECTION 3. Miscellaneous. The Agent hereby authorizes the Grantor and its successors, assigns or other legal representatives to file this Trademark Security Release with the United States Patent and Trademark Office and other necessary filings, in each case at the expense of the Grantor, to evidence the release and termination of the Agent’s security interest in the Released Trademark Collateral.
