**TERMINATION AND RELEASE OF SECURITY INTEREST IN
TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 24, 2019 (“Release”), is made by **QS CAPITAL STRATEGIES, L.P.** (“Lender”), in favor of **MILAN LASER HOLDINGS LLC** (the “Pledgor”).

WHEREAS, pursuant to (i) Security and Pledge Agreement dated as of January 24, 2018 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and between Lender and Pledgor and (ii) that certain Notice of Grant of Security Interest by and between Pledgor and Lender (the “Notice”) and recorded with the U.S. Patent and Trademark Office at Reel/Frame No. 6549/0301, Pledgor granted and conveyed to Lender a security interest in the entire right, title and interest of Pledgor in and to all of Pledgor's Trademarks;

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Lender agrees as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement.

SECTION 2. Termination and Release. Lender, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the entire right, title, and interest of Pledgor in and to all of Pledgor's Trademarks, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor's expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to its conflict of laws principles.


