**ASSIGNMENT OF TRADEMARKS AND
TRADEMARK REGISTRATIONS**

THIS ASSIGNMENT OF TRADEMARKS AND TRADEMARK REGISTRATIONS ("Assignment") is made pursuant to 15 U.S.C. § 1060, and entered into as of the effective date of May 28, 2019 (the "Effective Date"), by Bonamar Corp., a corporation registered in the state of Florida ("Assignor"), and Sea Delight, LLC, a limited liability corporation registered in the state of Florida, having its principal place of business located at 12510 W. Atlantic Blvd., Coral Springs, Florida 33071 ("Assignee").

WITNESSETH:

WHEREAS, Assignor is the sole owner of the trademarks registered with the United States Patent and Trademark Office ("USPTO") and of the trademark registered with the state of California, all shown on *Exhibit A* (the "Marks") and has been using the Marks continuously and conspicuously since at least as early as the date shown on the registration applications;

WHEREAS, Assignor desires to assign to Assignee all of its right, title and interest in and to the Marks, including the goodwill of the business to which the Marks pertain, and Assignee desires to acquire such rights and goodwill;

NOW, THEREFORE, for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Conveyance. Assignor hereby conveys, transfers and assigns, or, as applicable, memorializes the conveyance, transfer and assignment to Assignee, all of Assignor's right, title and interest in and to: (a) the Marks, together with the goodwill, if any, of that portion of Assignor's business symbolized by the Marks; (b) the Registrations; and (c) all claims and causes of action Assignor has or may have in connection with the Marks or Registrations. No rights are transferred hereby beyond the marks and registrations identified herein and only in the specific countries conveyed.

2. Recordation and Further Actions. Assignor authorizes the Commissioner for Trademarks of the USPTO and any other international, national, federal and state government officials to record and register this Trademark Assignment upon request by Assignee at assignees sole expense. Assignor shall execute any and all documents and take all other further actions as reasonably requested by Assignee to transfer ownership of the Assigned Trademarks including, but not limited to, assignments, transfers and related powers of attorney.

3. Counterparts. This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment.

4. Successors and Assigns. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

5. Governing Law. This Trademark Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Trademark Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance




with, the laws of the United States and the State of Florida without giving effect to any choice or conflict of law provision or rule (whether of the State of Florida or any other jurisdiction).

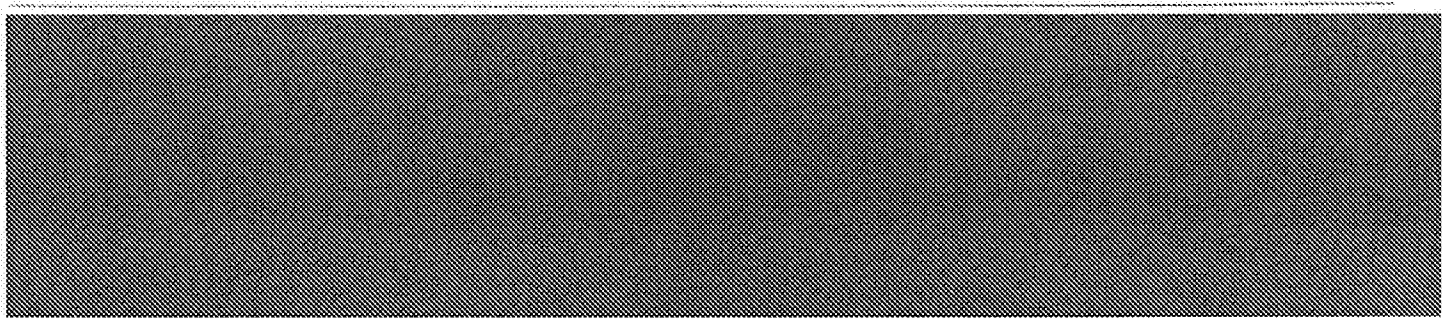





