**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “**Release**”), effective as of June 24, 2019, is made by MADISON CAPITAL FUNDING LLC, in its capacity as Agent for the Lenders (in such capacity, “**Agent**”), in favor of E+ ONCOLOGICS LOUISIANA, LLC, a Delaware limited liability company (“**Grantor**”). Capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Assignment (as defined below).

WITNESSETH:

WHEREAS, Agent and Grantor, were parties to that certain Trademark Security Agreement dated as of May 21, 2012 (the “**Assignment**”), pursuant to which Grantor granted a security interest to Agent in certain Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including, without limitation, the Trademarks set forth on Schedule A hereto; and

WHEREAS, the Assignment was recorded by the United States Trademark and Trademark Office on August 29, 2012, at Reel 4852 Frame 0695; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, terminates and discharges its lien on and security interest in all of Grantor’s right, title and interest in, to and under the following (collectively the “**Trademark Collateral**”):

a. each Trademark listed on Schedule A annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

b. all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of each such Trademark, or (b) injury to the goodwill associated with each such Trademark.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent’s right, title and interest in and to the Trademark Collateral.

3. Agent, without any representation, recourse or warranty, hereby terminates and cancels the Assignment.

4. This Release is made under and governed by the laws of the State of New York applicable to contracts made and to be performed entirely within the State of New York.
