RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

This Release of Security Interest in Patents and Trademarks (this "Release") is effective as of June 25, 2019, by THE HUNTINGTON NATIONAL BANK (the "Administrative Agent") in favor of HYDRAULAX PRODUCTS, LLC, a Pennsylvania limited liability company (the "Grantor"). All terms not herein defined, have the meanings set forth in the Security Agreement referenced below.

WHEREAS, pursuant to that certain Patent and Trademark Security Agreement, dated as of November 20, 2018, (the "Security Agreement"), Grantor granted to Administrative Agent, among other Trademark Collateral and Patent Collateral (as defined therein), a continuing security interest in and continuing lien upon all of the Grantor's right, title and interest to the patents and trademarks listed on Exhibit A hereto (collectively, the "Intellectual Property"); and


WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on November 21, 2018 at Reel/Frame 6487/0346.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Security Agreement, Administrative Agent hereby (i) automatically discharges, terminates and releases the continuing security interest and continuing lien upon, and automatically discharges, terminates and releases its security interest in, and all other rights, title and interest in and to, the Trademark Collateral and Patent Collateral, including the Trademark Collateral and Patent Collateral set forth on Exhibit A, without any recourse, representation or warranty, (ii) re-assigns to Grantor, any right, title or interest the Administrative Agent may have in, to or under the Trademark Collateral and Patent Collateral, including the Intellectual Property set forth on Exhibit A, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantor or their authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination, and (iii) agrees to execute and deliver any other documents and take any further action, in each case at Grantor's sole expense, which is reasonably requested by any Grantor and is necessary to effect the intent and purpose of this Release.
