**TERMINATION AND RELEASE OF  
SUBORDINATED TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF SUBORDINATED TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of June 30, 2014, is executed by ZFI INVESTMENTS LLC ("Secured Party") in favor of ZESTCASH, INC., a Delaware corporation ("ZestCash"), ZestFinance, Inc., a Delaware corporation ("ZestFinance," and together with ZestCash, the "Grantors"). All capitalized terms used in this Termination and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (defined below).

RECITALS

A. Pursuant to that certain Subordinated Trademark Security Agreement, dated as of June 24, 2013 (the "Trademark Security Agreement"), executed by Grantors in favor of Secured Party and the Security Agreement, Grantors granted to Secured Party a security interest in the Trademark Collateral (defined below).

B. The Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on June 25, 2013, at Reel/Frame 5055/0751 to evidence the security interest granted under the Trademark Security Agreement.

C. Secured Party agrees to terminate and release its security interest in the Trademark Collateral specified below and to file this Termination with respect to such release of its security interest as herein provided.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party expressly terminates and releases all of Secured Party's right, title and interest in, to and under the following (the "Trademark Collateral"):

- (a) all Trademarks of the Grantors, including those set forth on Schedule 1 hereto;
- (b) all Trademark Licenses of the Grantors in connection with the Trademark described in clause (a) above; and
- (c) all income, royalties, proceeds and liabilities due or payable, except to the extent received by Secured Party prior to the date of this Termination, or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.
