**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Agreement") is entered into as of June 18, 2019 (the "Effective Date") by and between PH Investment Holdings, LLC, a Delaware limited liability company ("PH Investment"), Performance Health Corporation, a Delaware corporation ("PH Corp"), PHW Intermediate Holdings, Inc., a Delaware corporation ("PHWIH"), Performance Health & Wellness Holdings, Inc., a Delaware corporation ("PHWH"), The Hygenic Corporation, a Delaware corporation ("Hygenic Corp"), Biofreeze IP Holdings, LLC (f/k/a Hygenic Intangible Property Holding, Co.), a Nevada limited liability company ("Biofreeze IP"), Performance Health, LLC, a Delaware limited liability company ("PH LLC"), and TheraPearl, LLC, a Maryland limited liability company (together with PH Investment, PH Corp, PHWIH, PHWH, Hygenic Corp, Biofreeze IP, and PH LLC, collectively, the "Assignors"), on the one hand, and Performance Health Group, LLC, a Delaware limited liability company ("Assignee") (Assignee and each Assignor, individually a "Party" and collectively the "Parties"), on the other hand.

WHEREAS, pursuant to that certain Contribution Agreement ("Contribution Agreement"), dated as of June 18, 2019, by and among the Assignors and Assignee, the parties thereto, which are affiliated parties, effected the separation of certain assets related to the BioFreeze and Therapearl businesses from the assets of the remainder of the parties' businesses; and

WHEREAS, in furtherance of the Contribution Agreement, each Assignor desires to convey, assign, transfer and deliver to Assignee, and Assignee desires to acquire, certain Intellectual Property Rights that are not related to the Biofreeze Business.

NOW, THEREFORE, in consideration of the mutual promises hereinafter set forth and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereto hereby agree as follows:

1. Definitions. Capitalized terms not otherwise defined herein shall have the respective meanings ascribed to them in the Contribution Agreement. For purposes of this Agreement, the following terms have the following meanings:

"Assigned IP" means: (a) the Intellectual Property Rights set forth on Schedule A (Patents and Patent Applications), Schedule B (Trademark Registrations and Applications), Schedule C (Copyright Registrations), and Schedule D (Internet Domain Names) attached hereto; (b) all rights in the names "Performance Health", "Hygenic", "THERA-BAND", "Theraplast" and "Therarobics"; and (c) solely to the extent related to, developed for or otherwise used in the PH Business, all other Intellectual Property Rights, in each case of (a) through (c), together with all goodwill associated therewith and all income, royalties, damages and payments due or payable with respect thereto as of the Closing or thereafter (including damages and payments for past, present or future infringements, misappropriations, dilutions, or other violations thereof), the right to sue and recover for past infringements, misappropriations, dilutions, or other violations thereof as of the Closing, and any and all corresponding rights that, now or hereafter, may be secured throughout the world.

2. Assignment. Each Assignor hereby irrevocably conveys, assigns, transfers and delivers and agrees to sell, convey, assign, transfer, and deliver to Assignee such Assignor's entire right, title, and interest in and to the Assigned IP. Each Assignor hereby irrevocably waives any "moral rights", "author's special rights" or other rights with respect to attribution of authorship or integrity in relation to the Assigned IP.

3. Further Assurances. From time to time after the Effective Date, and for no further consideration, each Assignor shall execute, acknowledge and deliver such assignments, transfers, consents, assumptions and other documents and instruments and take such other actions as may be requested by Assignee to more effectively sell, assign, convey, deliver or transfer to or vest in Assignee, all Assigned IP, and to confirm and evidence such sale, assignment, conveyance, transfer or delivery. Each Assignor, upon Assignee's request, shall take all further actions, and provide Assignee all such cooperation and assistance (including, but not limited to, the execution and delivery of any and all affidavits, declarations, oaths, powers of attorney and other documentation), to more fully effectuate the purposes of this Agreement, including, but not limited to, assisting Assignee in preserving or perfecting its rights in the Assigned IP and the filing of applications for the registration of any Intellectual Property Rights in the Assigned IP. Should Assignee opt to take action against any actual or suspected infringers, diluters, or other violators of any of the Assigned IP, upon Assignee's request, each applicable Assignor shall join Assignee as a necessary party in any such action (or proceeding related thereto) and to provide Assignee all cooperation in connection therewith including, but not limited to, by offering testimony and providing specimens of use.

4. Counterparts; Successors. This Agreement may be executed in one or more counterparts (including by means of telecopied signature pages), each of which shall be deemed to be an original, but all of which shall be one and the same document. This Agreement and any signed agreement or instrument entered into in connection with this Agreement, and any amendments hereto or thereto, may be executed in one or more counterparts (including by means of telecopied signature pages), each of which shall be deemed an original, but all of which shall constitute one and the same document. This Agreement and all of the provisions hereof shall be binding on and inure to the benefit of the parties hereto and their respective successors and permitted assigns, except that neither this Agreement nor any of the rights, interests or obligations hereunder may be assigned or delegated by either Party without the prior written consent of the other Party hereto.. Except as otherwise expressly provided herein, nothing expressed or referred to in this Agreement will be construed to give any person, other than the Parties hereto and such permitted assigns, any legal or equitable right, remedy, or claim under or with respect to this Agreement or any provision of this Agreement.

5. Governing Law. ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THIS AGREEMENT AND THE SCHEDULES ATTACHED HERETO SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF DELAWARE, WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OR CONFLICT OF LAW RULES OR PROVISIONS (WHETHER OF THE STATE OF DELAWARE OR ANY OTHER JURISDICTION) THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANY JURISDICTION OTHER THAN THE STATE OF DELAWARE.
