ASSIGNMENT OF TRADEMARKS

ASSIGNOR agrees: (a) to execute (i) all necessary papers throughout the world to be used in connection with the trademarks as ASSIGNEE, its successors, assigns, or legal representatives, may deem necessary or expedient, and without further consideration to ASSIGNOR, (ii) all papers in connection with any cancellation, opposition, legal, or other proceedings throughout the world to maintain, protect, or enforce, or otherwise relating to, the trademarks, and (iii) all papers and documents which may be necessary throughout the world in connection with the preparation and filing of any foreign applications in connection with the trademarks; (b) to cooperate with ASSIGNEE at ASSIGNEE's expense in every way reasonably possible in obtaining evidence and going forward in any such proceedings throughout the world; and (c) at ASSIGNEE's expense to perform all other affirmative acts which in ASSIGNEE's, and its successors', assigns', or legal representatives', reasonable discretion may be necessary or desirable throughout the world to maintain, protect, or enforce the trademarks. These obligations of assistance by ASSIGNOR shall continue for so long as ASSIGNEE, and its successors, assigns, or legal representatives, may require such assistance from ASSIGNOR.
