THIRD: The first Article of the Articles of Organization of the Company is hereby replaced in its entirety with the following:

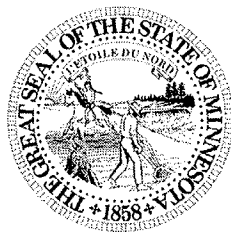
