## RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of June 27, 2019, (this "Release") is made by JPMorgan Chase Bank, N.A. (successor to Manufacturers Hanover Trust Company), as agent (the "Agent") under that certain Supplement to Trademark Security Agreement, dated as of April 16, 1991 (the "IP Security Agreement") to Covalence Specialty Adhesives, LLC (the "Grantor"),

WHEREAS, pursuant to the IP Security Agreement which was recorded on May 30, 1991, in the records of the United States Patent and Trademark Office at Reel/Frame 0789/0290, the Grantor (via its predecessor in interest to the Trademarks (as defined below), The Kendall Company) granted a security interest in and lien upon all of Grantor's right, title and interest in, to and under the trademarks set forth on Schedule A ("Trademarks") attached hereto;

WHEREAS, the Grantor has requested and the Agent has agreed to terminate, release, relinquish and discharge its security interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademarks pursuant to the IP Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent does hereby, in each case, without recourse or representation or warranty, express or implied, of any kind or nature whatsoever:

- 1) Release of Security Interest. (a) terminate the liens and security interest created under the IP Security Agreement in the Trademarks; (b) release its security interest in the Trademarks; and (c) relinquish and discharge any and all rights, title and interest it has in and the security interest granted to Agent in the Trademarks.
- 2) Further Assurances. (a) authorize Grantor or its authorized representatives to record this Release with the U.S. Patent and Trademark Office and (b) authorize and request that the U.S. Patent and Trademark Office note and record the existence of this Release hereby given, at Grantor's sole cost and expense and (c) agree to duly execute, acknowledge, procure, and deliver any further documents and to do other such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.

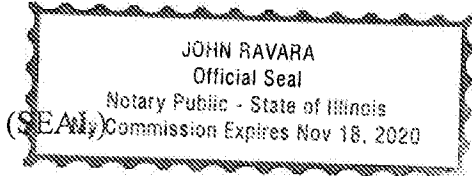
