**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of May 15, 2019, and made by **INDIANA FINANCE AUTHORITY**, a body corporate and politic, not a State agency, but an independent instrumentality exercising essential public functions, organized and existing under IC 4-4-11, as amended, on behalf of itself and as collateral agent (the "Grantee") to **CLABBER GIRL CORPORATION**, an Indiana corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark and Patent Security Agreement dated as of July 24, 2015, made by Grantor in favor of Grantee and Indiana Motorsports Commission, established and existing pursuant to Indiana Code 5-1-17.5, as amended (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on July 28, 2015, at Reel/Frame 5586/0421; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks" as used herein shall mean all of the Grantor's right, title and interest in every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto.


2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.


