SECURITY AGREEMENT (SHORT FORM) (TRADEMARK)

This Security Agreement (Short Form) (Trademark) (“Agreement”) is made as of June 27, 2019 between Agave Loco LLC, a limited liability company organized and existing under the laws of the State of Illinois, having offices at 1175 Corporate Woods Parkway, Suite 218, Vernon Hills, IL, 60061 (the “Grantor”) and MUFG Union Bank, N.A., a national banking association formed under the laws of the United States, having offices at 350 California Street, 10th Floor, San Francisco, CA 94104-1402 (the “Secured Party”);

WHEREAS, Grantor is the owner of the trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, including those identified on Schedule 1 attached hereto (collectively the “Trademarks”); and

WHEREAS, Grantor is obligated to the Secured Party under the terms of that certain (a) Security Agreement (All Assets) by and among Grantor and the Secured Party dated as of May 21, 2015 (the “All Assets Security Agreement”) and (b) Security Agreement (Intellectual Property) by and among Grantor and the Secured Party dated as of May 21, 2015 (the “IP Security Agreement”) and together with the All Assets Security Agreement, the “Security Agreements”);

NOW THEREFORE, pursuant to the terms of the Security Agreements and for good and valuable consideration, the receipt of which is hereby acknowledged, Grantor confirms that it has granted to the Secured Party a security interest in all Grantor’s right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by such Trademarks and all amendments, extensions, renewals and extensions of such Trademarks.

Grantor does hereby acknowledge and affirm that the rights and remedies of Secured Party with respect to the foregoing security interest in the Trademarks confirmed hereby are more fully set forth in the Security Agreements, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein, and that this document is subject to the terms and conditions of the Security Agreements.
