RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 1, 2019 (the “Effective Date”), is made by Credit Suisse AG, Cayman Islands Branch, in its capacity as collateral agent for the Secured Parties (the “Agent”), in favor of Sirius Computer Solutions, Inc. (“Sirius”), Force 3, LLC (“Force 3”) and Forsythe Technology, Inc. (“Forsythe”) and together with Sirius and Force 3, the “Grantors”).

WHEREAS, pursuant to that certain Second Lien Guarantee and Collateral Agreement, dated as of October 30, 2015, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), the Grantors granted to the Agent, in its capacity as Agent, a security interest in and to certain collateral;

WHEREAS, pursuant to the Security Agreement, Sirius executed and delivered a Second Lien Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of October 30, 2015 (the “2015 Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on November 3, 2015 at Reel/Frame 5659/0207;

WHEREAS, pursuant to the Security Agreement, Force 3 executed and delivered a Second Lien Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of May 16, 2016 (the “2016 Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on May 17, 2016 at Reel/Frame 5795/0272;

WHEREAS, pursuant to the Security Agreement, Forsythe executed and delivered a Second Lien Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of October 31, 2017 (the “2017 Trademark Security Agreement”), which was recorded with the United States Patent and Trademark Office on November 8, 2017 at Reel/Frame 6199/0520;

WHEREAS, pursuant to the Security Agreement, Forsythe executed and delivered a Second Lien Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of October 31, 2017 (the “Supplemental 2017 Trademark Security Agreement” and together with the 2015 Trademark Security Agreement, the 2016 Trademark Security Agreement and the 2017 Trademark Security Agreement, the “Trademark Security Agreements”), which was recorded with the United States Patent and Trademark Office on November 9, 2017 at Reel/Frame 6200/0716;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including the trademark registrations and applications set forth Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral and all goodwill associated therewith originally granted to the Agent under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.


3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.

4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), necessary or reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO ITS PRINCIPLES OR RULES OF CONFLICT OF LAWS TO THE EXTENT SUCH PRINCIPLES OR RULES ARE NOT MANDATORILY APPLICABLE BY STATUTE AND WOULD REQUIRE OR PERMIT THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION.
