**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of July 1, 2019 (the "Release"), is made by ANTARES CAPITAL LP, in its capacity as administrative agent (the "Administrative Agent"), in favor of ARR-MAZ PRODUCTS, L.P. (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement (as defined below).

**W I T N E S S E T H**

WHEREAS, the Grantor and the Administrative Agent entered into that certain Amended and Restated Security Agreement, dated as of June 27, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed the (i) Patent Security Agreement, dated as of June 27, 2017 (the "Patent Security Agreement"), and recorded with the U.S. Patent and Trademark Office ("USPTO") on June 30, 2017 at Reel/Frame No. 043070/0804 and the (ii) Trademark Security Agreement, dated as of June 27, 2017 (the "Trademark Security Agreement"), and recorded with the USPTO on June 30, 2017 at Reel/Frame No. 6098/0155, pursuant to which the Grantor pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all of its Patents and Trademarks included in the Collateral;

WHEREAS, the Grantor has requested that the Administrative Agent release its security interest in all right, title and interest in, to and under all of its Patents and Trademarks included in the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby **DISCHARGES, TERMINATES and RELEASES**, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Patents and Trademarks of Grantor included in the Collateral, including the issued patents, patent applications, trademark registrations, and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Patents and Trademarks is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Patents and Trademarks under the Security Agreement, the Patent Security Agreement, and the Trademark Security Agreement.
