**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of July 1, 2019 (the "Release"), is made by ANTARES CAPITAL LP (successor to General Electric Company ("General Electric"), in its capacity as administrative agent (the "Administrative Agent")), in favor of ARR-MAZ PRODUCTS, L.P., ARR-MAZ CUSTOM CHEMICALS, INC., ARMAZ SPECIALTY CHEMICALS, INC., and CUSTOM CHEMICALS CORPORATION (individually, each a "Grantor", and, collectively, the "Grantors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement.

WITNESSETH

WHEREAS, the Grantors and the Administrative Agent entered into that certain Security Agreement, dated as of December 24, 2012 (as amended, restated, amended and restated, supplemented or otherwise from time to time, including pursuant to the Amended and Restated Security Agreement, dated as of June 27, 2017, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantors executed the (i) Patent Security Agreement, dated as of December 24, 2012 (the "Patent Security Agreement"), and recorded with the U.S. Patent and Trademark Office ("USPTO") on December 24, 2012 at Reel/Frame Nos. 029529/0862, 29538/0673, and 29538/0691 and the (ii) Trademark Security Agreement, dated as of December 24, 2012 (the "Trademark Security Agreement"), and recorded with the USPTO on December 24, 2012 at Reel/Frame Nos. 4928/0423, 4928/0431, and 4928/0439, pursuant to which the Grantors pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all Patents and Trademarks of the Grantors included in the Collateral;

WHEREAS, pursuant to the Assignment of Intellectual Property Security Agreements, dated as of June 27, 2017 (the "Assignment"), and recorded with the USPTO on June 29, 2017 at Reel/Frame No. 043061/0511 and on June 30, 2017 at Reel/Frame No. 6097/0110, General Electric assigned and transferred to Antares Capital LP and its successors and assigns, all of its rights, title and interest in and to the Patent Security Agreement and the Trademark Security Agreement;

WHEREAS, the Grantors have requested that the Administrative Agent release its security interest in all right, title and interest in, to and under all of its Patents and Trademarks included in the Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Patents and Trademarks of Grantors included in the Collateral, including the issued patents, patent applications, trademark registrations, and trademark applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Patents and Trademarks is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantors, without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Patents and Trademarks under the Security Agreement, the Patent Security Agreement, the Trademark Security Agreement, and the Assignment.
