RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of June 27, 2019 (this “**Release**”) is made by GOLDMAN SACHS BANK USA, for itself and in its capacity as Collateral Agent) (the “**Collateral Agent**”).

WHEREAS, pursuant to certain Trademark Security Agreements dated as of July 1, 2014 (and recorded with the United States Patent and Trademark Office (“**PTO**”) on July 2, 2014 at Reel 5315, Frame 0116), September 30, 2014 (and recorded with the PTO on September 30, 2014 at Reel 5371, Frame 0716), January 30, 2015 (not recorded with the PTO), April 30, 2015 (and recorded with the PTO on June 3, 2015 at Reel 5545, Frame 0028), September 1, 2017 (and recorded with the PTO on September 7, 2017 at Reel 6148, Frame 0228), May 18, 2018 (and recorded with the PTO on May 23, 2018 at Reel 6335, Frame 0644), August 14, 2018 (and recorded with the PTO on August 14, 2018 at Reel 6413, Frame 0644), November 16, 2018 (and recorded at the PTO on November 20, 2018 at Reel 6485, Frame 0906), and February 19, 2019 (not recorded with the PTO) (each of such Trademark Security Agreements, as amended, supplemented or otherwise modified from time to time, a “**Trademark Security Agreement**” and collectively, the “**Trademark Security Agreements**”); capitalized terms used herein but not defined herein shall have the meanings assigned to them in each of the Trademark Security Agreements) in favor of the Collateral Agent, each of VERDESIAN LIFE SCIENCES U.S., LLC, VERDESIAN LIFE SCIENCES, LLC, PLANT PROTECTANTS, LLC, RODE-TROL, LLC, NORTHWEST AGRICULTURAL PRODUCTS, LLC, INTX MICROBIALS, LLC, QC LLC, ADD-IRON LLC, QC HOLDINGS I, LLC, or SPECIALTY FERTILIZER PRODUCTS, LLC, as applicable (each, a “**Grantor**”, and collectively, the “**Grantors**”), pledged and granted to the Collateral Agent for itself and the benefit of certain secured parties, a security interest in all of such Grantors’ right, title and interest in, to and under the following (together with the Trademark Collateral under each Trademark Security Agreement, the “**Released Trademark Collateral**”): all United States, and foreign trademarks, trade names, trade dress, corporate names, company names, business names, fictitious business names, Internet domain names, service marks, certification marks, collective marks, logos, other source or business identifiers, designs and general intangibles of a like nature, whether or not registered, and with respect to any and all of the foregoing: (i) all registrations and applications therefor including, without limitation, the registrations and applications listed or required to be listed in Schedule A attached hereto, (ii) all extensions or renewals of any of the foregoing, (iii) all of the goodwill of the business connected with the use of and symbolized by any of the foregoing, (iv) the right to sue or otherwise recover for any past, present and future infringement, dilution or other violation of any of the foregoing or for any injury to the related goodwill, (v) all Proceeds (under each of the Trademark Security Agreements) of the foregoing, including, without limitation, license fees, royalties, income, payments, claims, damages, and proceeds of suit now or hereafter due and/or payable with respect thereto, and (vi) all other rights of any kind accruing thereunder or pertaining thereto throughout the world.

WHEREAS, the Collateral Agent has agreed to: (i) irrevocably release and terminate in its entirety its security interest and lien in, to and under, and discharge, quit claim and relinquish unto the applicable Grantor (in each case without recourse and without any representation or warranty) all right, title and interest it has in, to and under, the Released Trademark Collateral; (ii) terminate each of the Trademark Security Agreements; and (iii) dissolve any and all liens and encumbrances respecting the Released Trademark Collateral under each of the Trademark Security Agreements, the Collateral Agreement or otherwise.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent hereby (i) irrevocably releases and terminates in its entirety its security interest and lien in, to and under, and discharges, quit claims and relinquishes unto the applicable Grantor (in each case without recourse and without any representation or warranty) all right, title and interest it has in, to and under, the Released Trademark Collateral; (ii) terminates each of the Trademark Security Agreements; and (iii) dissolves any and all liens and encumbrances respecting the Released Trademark Collateral under each of the Trademark Security Agreements, the Collateral Agreement or otherwise.

2. The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks record this Release.

3. This Release and the transactions contemplated hereby, and all disputes between the parties under or relating to this Release or the facts or circumstances leading to its execution, whether in contract, tort or otherwise, shall be construed in accordance with and governed by the laws (including statutes of limitation) of the State of New York, without regard to conflicts of law principles that would require the application of the laws of another jurisdiction.
