**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “**Release**”), dated as of July 1, 2019, is made by **BANK OF AMERICA, N.A.** as agent (the “**Agent**”) with offices located at 333 South Hope Street, 23th Floor, Los Angeles, California 90071 (the “**Assignor**”), in favor of **CYNARA WORLDWIDE SOURCING INC.**, a California corporation with offices located at 9491 N. Fort Washington Road, Suite 102, Fresno, California 93730 (“**Assignee**”).

**WITNESSETH:**

**WHEREAS**, the Assignee and the Assignor are parties to that certain Loan and Security Agreement, dated as of September 20, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”).

**WHEREAS**, pursuant to the Security Agreement, the Assignee granted a continuing security interest in and continuing lien upon, the trademarks and trademark applications set forth on Schedule I (collectively, the “**CWS Trademark Collateral**”) to the Agent for the benefit of itself and the Secured Parties and delivered to the Agent a Notice of Grant of Security Interest in Trademarks (the “**Notice of Security Interest**”) to the Assignor;

**WHEREAS**, the Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office on September 21, 2017 at Reel 6158 / Frame 0402; and

**WHEREAS**, the Assignee desires that the Assignor terminate and release its lien on and security interest in and to all right, title and interest in, to and under all of the CWS Trademark Collateral.

**NOW THEREFORE**, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledges, the Assignor agrees as follows:

(1) Termination and Release. The Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse of any kind, its continuing lien on and continuing security interest in and to all right, title and interest in, to and under the CWS Trademark Collateral, including the trademarks and trademark applications listed on Schedule I attached hereto, and reassigns and transfers to the Assignee all right, title and interest that the Assignor may have in the CWS Trademark Collateral.

(2) Recordation. The Assignor hereby authorizes the Assignee, or the Assignee’s authorized representative, to record this Release with the United States Patent and Trademark Office.






