This is in response to the June 4, 2019 Notice of Non-Recordation Notice.

The Assignment Branch issued a notice of non-recordation on June 4, 2019 in response to the merger document submitted in the above referenced registration.

Registrant advises that the merger document submitted is acceptable. The document submitted states, among other things, that:


- Viña Santa Helena S.A. has been dissolved;
- The totality of the shares of Viña Santa Helena S.A. are now held by Viña San Pedro Tarapacá S.A.; and finally
- "As a result of that as expressed in the preceding clauses, all assets of "Viña Santa Helena S.A.", whatever their nature, have automatically, by operation of law, been incorporated into the assets of "Viña San Pedro Tarapacá S.A." and it holds title to all items that comprise the former's assets, without any limitation or exclusion. In the same way, the absorbing company is responsible for all of the transferable liabilities and obligations of "Viña Santa Helena S.A.".

The document previously submitted evidences the merger.

Applicant also attaches further information that shows that in the Official Gazette of the Republic of Chile, Viña Santa Helena S.A. was dissolved and Viña San Pedro Tarapacá S.A. now holds all shares of the previous company Viña Santa Helena S.A. English translations of these documents are provided along with the verification of those translations.

It is respectfully submitted that the merger is evidenced by the documents submitted in this proceeding. It is requested that the USPTO record the merger.
