DEED OF ASSIGNMENT OF TTC INTELLECTUAL PROPERTY RIGHTS

This Deed is made on the 28 day of SEPTEMBER 2018

BETWEEN

1. **Tru-Test Corporation Limited** a company incorporated in New Zealand under company number 104108 and having its registered office at 25 Carbine Road, Mount Wellington, Auckland (the "Assignor"); and
2. **DATAMARS SA** at Via ai Prati CH6930 Bedano-Lugano, Switzerland (the "Assignee").

RECITALS

- A. The Assignor is the owner of the TTC IP Assets .
- B. Pursuant to the Agreement, the Assignor has sold and the Assignee has purchased certain businesses and assets of the Assignor, including all Intellectual Property Rights for and used in connection with the said businesses.
- C. Pursuant to the Agreement, the Assignor and the Assignee wish to record the transfer and assignment of the TTC IP Assets from the Assignor to the Assignee for the purpose of recording such transfer and assignment on any applicable register.
- D. The Assignor and the Assignee have made this Deed accordingly.

1. DEFINITIONS

- 1.1 "Agreement" means the Agreement for Sale and Purchase of Shares and Assets dated 4 May 2018;
- 1.2 "Businesses" has the same meaning as set out in the Agreement;
- 1.3 "Completion" has the same meaning as set out in the Agreement;
- 1.4 "Deed" means this Deed of Assignment of the TTCIP Assets ;
- 1.5 "Domain Names" the registered domain names listed in schedule 2;
- 1.6 "Intellectual Property" means trade marks, service marks, logos, trade names, business names, domain names, patents, inventions, design rights, copyrights (including without limitation, software, websites and database rights), know-how and all similar rights, including without limitation, any registrations of such rights, applications and rights to apply for such registrations;
- 1.7 "Trade Marks" means the registered trade marks listed in Schedule 1; and

1.8 "TTC IP Assets " means all rights and interests of the Assignor (whether as owner, licensee or otherwise) in and to the Intellectual Property used by or in relation to the Businesses, including but not limited to the Trade Marks and the Domain Names.

2. OPERATIVE PART

2.1 For good and valuable consideration, the receipt and legal sufficiency of which the Assignor hereby acknowledges, the Assignor hereby assigns to the Assignee absolutely with effect from Completion (and to the extent that such assignment has already been effected under the Agreement, now confirms the assignment to the Assignee of), all of the Assignor's right, title and interest in the TTC IP Assets , including all statutory and common law rights attaching thereto, and all rights of action, powers and benefits of the same, including the right to sue for past infringement and to retain any damages obtained as a result of such action to hold the above unto and to the Assignee absolutely.

3. COUNTERPARTS

3.1 This Deed may be executed in two or more counterparts each of which shall be deemed an original, but all of which together shall constitute the same instrument.

4. DELIVERY

4.1 Without limiting any other mode of delivery this Deed will be delivered by each of the parties to this Deed on the earlier of:

- (a) physical delivery of an original of this Deed, executed by that party, into the custody of the other party or its solicitors; or
- (b) transmission in electronic form by any means of electronic communication by that party, its solicitors or any other person authorised in writing by that party of a facsimile, photocopied or scanned copy of an original of this Deed, executed by that party, to the other party or its solicitors.

5. WAIVER

5.1 No failure or delay by any party in exercising any right, power or privilege under this Deed will operate as a waiver of such right, power or privilege, nor will any single or partial exercise preclude any other or further exercise of any right, power or privilege under this Deed.

6. FURTHER ASSURANCES

6.1 The Assignor will, promptly on request of the Assignee, sign all documents and do all things necessary to give effect to the intention of the parties as reflected in this Deed, including, without limitation, by promptly at the Assignee's request (to the extent the Assignor has not already done so):

- (a) providing the Assignee with such password and technical information as is necessary for the Assignee to use the Domain Names as intended by the Agreement;

- (b) taking such steps as the Assignee may reasonably require to have the Assignee entered on the relevant registers as owner of the Trade Marks and the Domain Names.


