WHEREAS, the Parties desire to confirm the acquisition of the Trademarks and related goodwill for purposes of recording same in the United States Patent and Trademark Office;

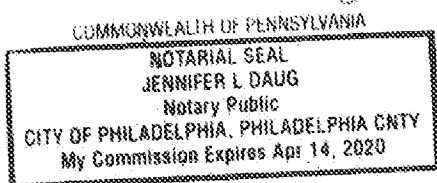
