**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of June 24, 2019 by **SILICON VALLEY BANK** (the "*Bank*"), in favor of **THE WHITE STONE GROUP, INC.**, a Tennessee corporation (the "*Grantor*").

WHEREAS, Grantor executed and delivered a Trademark Security Agreement, dated as of August 28, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting the Bank a security interest in and lien on the Trademarks (as defined in the Agreement), including the trademarks and trademark applications set forth in Schedule I attached hereto, which Agreement was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 28, 2015, at Reel 5611, Frame 0465;

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:


1. terminates the Agreement and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
