**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of June 24, 2019 by **SILICON VALLEY BANK** (the "*Bank*"), in favor of **EA HOLDINGS AGGREGATOR, LLC**, a Delaware limited liability company (the "*Grantor*").

**WHEREAS**, Grantor executed and delivered a Trademark Security Agreement, dated as of September 20, 2017 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting the Bank a security interest in and lien on the Trademarks (as defined in the Agreement), including the trademarks and trademark applications set forth in Schedule I attached hereto, which Agreement was recorded with the United States Patent and Trademark Office ("*USPTO*") on September 20, 2017, at Reel 6157, Frame 0554;

**WHEREAS**, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

**WHEREAS**, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:


