**RELEASE OF SECURITY INTERESTS AND SECURITY AGREEMENTS  
WITH RESPECT TO INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTERESTS AND SECURITY AGREEMENTS WITH RESPECT TO INTELLECTUAL PROPERTY** (this "Release") is made as of June 26, 2019 ("Effective Date") in favor of ZEROFOX, INC., a Delaware corporation ("Grantor"), by SILVER LAKE WATERMAN FUND II, L.P., a Delaware limited partnership, as agent on behalf of certain lenders (the "Agent"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

**WHEREAS**, Grantor and the Agent entered into a certain Intellectual Property Security Agreement by and between Grantor and the Agent dated June 1, 2017 (the "Security Agreement"), wherein Grantor granted to the Lender, a security interest in and to: (i) the Grantor's Trademarks as set forth on Exhibit A attached hereto; (ii) the Grantor's Patents set forth on Exhibit B attached hereto; and (iii) the Grantor's Copyrights set forth on Exhibit C attached hereto (collectively, the "Collateral");

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on June 1, 2017 at Reel 6075, Frame 0176, for the purposes of recording security interests with respect to the trademarks of the Grantor, including those items set forth on Exhibit A attached hereto and at Reel 042568, Frame 0264, for the purposes of recording security interests with respect to the patents of the Grantor, including those items set forth on Exhibit B attached hereto;

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to the Lender and requests a specific release of the security interest granted and recorded against the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates the Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, or other right, title and interest it may have in, to and under the Collateral, together with the goodwill of the business symbolized thereby, including all security interests pledged and granted to the Lender by the Grantor in the agreements and documents recorded with the USPTO on June 1, 2017 at Reel 6075, Frame 0176 and at Reel 042568, Frame 0264, including but not limited to the security interest in the trademarks, trademark applications, patents and/or patent applications described on Exhibit A and Exhibit B attached hereto.

The Agent acknowledges that no demand was made upon the Grantor, and thus, no assignment of the Collateral was ever made.
