RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, pursuant to the Security Agreement, the Grantors executed and delivered, as applicable, (i) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Healthfield, LLC in favor of the Agent (the “Healthfield Trademark Security Agreement”), (ii) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by IntegraCare Holdings, Inc. in favor of the Agent (the “IntegraCare Trademark Security Agreement”), (iii) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Home Health Services, Inc. in favor of the Agent (the “Home Health Trademark Security Agreement”), (iv) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Girling Health Care, Inc. in favor of the Agent (the “Girling Trademark Security Agreement”), (v) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Gentiva Health Services, Inc. in favor of the Agent (the “Gentiva Trademark Security Agreement”), (vi) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Senior Home Care, Inc. in favor of the Agent (the “Senior Home Trademark Security Agreement”), (vii) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Odyssey Healthcare, Inc. in favor of the Agent (the “Odyssey Trademark Security Agreement”), (viii) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Gentiva Health Services Holding Corp. in favor of the Agent (the “Gentiva Health Trademark Security Agreement”), (ix) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by Harden Healthcare, LLC in favor of the Agent (the “Harden Trademark Security Agreement”), (x) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 2, 2018, made by The American Heartland Hospice Corp. in favor of the Agent (the “American Trademark Security Agreement”), (xi) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 11, 2018, made by Community Health, LLC in favor of the Agent (the “Community Trademark Security Agreement”), (xii) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 11, 2018, made by New Century Hospice, Inc. in favor of the Agent (the “New Century Trademark Security Agreement”) and (xiii) a Notice and Confirmation of Grant of Security Interest in Trademarks, dated as of July 11, 2018, made by Curo Health Services, LLC in favor of the Agent (the “Curo Trademark Security Agreement”), and together with the Healthfield Trademark Security Agreement, the IntegraCare Trademark Security Agreement, the Home Health Trademark Security Agreement, the Girling Trademark Security Agreement, the Gentiva Trademark Security Agreement, the Senior Home Trademark Security Agreement, the Odyssey Trademark Security Agreement, the Gentiva Health Trademark Security Agreement, the Harden Trademark Security Agreement, the American Trademark Security Agreement, the Community Trademark Security Agreement and the New Century Trademark Security Agreement, the “Trademark Security Agreements”), for recordal with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the Trademark Collateral, including, without limitation, the trademark registrations and applications set forth Schedule 2 attached hereto, arising under the Security Agreement and the Trademark Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the Trademark Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to each Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), necessary or reasonably requested by such Grantor, at such Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO ITS PRINCIPLES OR RULES OF CONFLICT OF LAWS TO THE EXTENT SUCH PRINCIPLES OR RULES ARE NOT MANDATORILY APPLICABLE BY STATUTE AND

WOULD REQUIRE OR PERMIT THE APPLICATION OF THE LAWS OF ANOTHER
JURISDICTION.


