**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN UNITED STATES TRADEMARKS**

TERMINATION AND RELEASE dated as of July 3, 2019, from JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent") to WEATHERFORD/LAMB, INC. (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the U.S. Pledge and Security Agreement, dated as of May 9, 2016 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Grantor granted a security interest (the "Security Interest") to the Administrative Agent in certain collateral;

WHEREAS, pursuant to that certain Confirmatory Grant of Security Interest in United States Trademarks dated as of June 7, 2016, by the grantor in favor of the Administrative Agent (the "Trademark Security Agreement"), Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the Security Interest to the Administrative Agent specifically in the trademarks listed on Exhibit A attached hereto (the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 8, 2016 at Reel 5810 and Frame 0456.

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement.
2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges, without recourse, representation or warranty, its Security Interest in the Trademarks, and any right, title or interest of the Administrative Agent in such Trademarks shall hereby cease and become void.
3. Governing Law. This Termination and Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the internal laws of the State of New York.
