## TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS** (this “*Termination and Release*”) is granted as of March 1, 2019 by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as administrative agent and collateral agent for itself and certain other credit parties (the “*Grantee*”), in favor of **ADVANCED SPORTS ENTERPRISES, INC.** (formerly known as and successor by merger to Nova Designs, Inc.), a North Carolina corporation (the “*Grantor*”),

**WHEREAS**, the Grantor has requested that the Grantee provide a document suitable for recording with the USPTO to evidence the release of the Grantee’s security interests in and liens on the Trademark Collateral as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the grants and releases, terminates and discharges all liens and security interests in the Grant, all right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including those trademarks and trademark applications identified in Schedule A hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
