PARTIAL RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS dated as of July 5, 2019 (this "Partial Release"), by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Administrative Agent") in favor of CALIBER COMPANY ("Caliber"), SAVAGE SPORTS HOLDINGS, INC. ("Savage Holdings"), SAVAGE SPORTS CORPORATION ("Savage Corporation"), SAVAGE ARMS, INC. ("Savage Arms") and SAVAGE RANGE SYSTEMS, INC. ("Savage Range" and together with Caliber, Savage Holdings, Savage Corporation and Savage Arms, the "Grantors"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the ABL Credit Agreement (as defined below) or the ABL Security Agreement (as defined below).

A. Reference is made (i) that certain Asset-Based Revolving Credit Agreement dated as of November 19, 2018, as amended by that certain First Amendment to Asset-Based Revolving Credit Agreement dated as of December 19, 2018 (as the same heretofore may have been amended, restated, supplemented, extended, renewed, replaced or otherwise modified from time to time, herein referred to as the "ABL Credit Agreement"), among Vista Outdoor Inc., a Delaware corporation (the "Borrower"), the additional Borrowers from time to time party thereto, the Lenders from time to time party thereto and Wells Fargo Bank, National Association, as Administrative Agent for the Lenders (the "Administrative Agent"), (ii) that certain ABL Security Agreement dated as of November 19, 2018 (as the same heretofore may have been amended, restated, supplemented, extended, renewed, replaced or otherwise modified from time to time, herein referred to as the "ABL Security Agreement"), among the Borrower, the Grantors, the other subsidiaries of the Borrower from time to time party thereto and Wells Fargo Bank, National Association, as Administrative Agent for the Secured Parties and (iii) that certain ABL Intellectual Property Security Agreement dated as of November 19, 2018, as supplemented by that certain ABL Intellectual Property Security Agreement Supplement dated as of February 22, 2019, among Savage Arms, Savage Range and the other grantors listed therein and the Administrative Agent (the "ABL IP Security Agreement" and together with the ABL Credit Agreement and the ABL Security Agreement, the "ABL Security Documents").

B. Pursuant to the ABL Security Documents, the Grantors granted to the Administrative Agent, for the benefit of the holders of the Obligations, a security interest in all right, title or interest of the Grantors in, among other things, the patents and trademarks of the Grantors set forth on Schedule I (the "Released IP Collateral"), which security interests were recorded with the United States Patent & Trademark Office on November 20, 2018 at Reel/Frame 047609/0001 and 6486/0112 and on February 25, 2019 at Reel/Frame 048421/0556 and 6571/0904.

C. The Grantors hereby notify the Administrative Agent that Caliber is party to that certain Stock Purchase Agreement dated as of July 5, 2019 (the

"Acquisition Agreement"), by and among Vista Outdoor Operations, LLC, a Delaware limited liability company (the "Seller"), Caliber, Borrower and Long Range Acquisition LLC (the "Purchaser"), pursuant to which the Seller has agreed to transfer the Company Shares (as defined in the Acquisition Agreement) to the Purchaser.

Pursuant to Section 30 of the ABL Security Agreement and Section 9.09 of the ABL Credit Agreement, and acting in reliance upon (i) that certain Officer's Certificate dated the date hereof, the Administrative Agent does hereby release, relinquish and discharge any and all security interests it has against the Released IP Collateral, and hereby reassigns to the Grantors any and all right, title, and interest that the Administrative Agent may have in or to such Released IP Collateral, *provided, however,* that it is understood and agreed that such release, relinquishment, discharge and reassignment is made without recourse, representation, warranty or other assurance of any kind (express or implied).

This Partial Release is applicable only and solely with respect to the Released IP Collateral and to no other collateral arising under the ABL IP Security Agreement or the ABL Security Agreement (such collateral, the "Retained Collateral"). The Administrative Agent retains all security interests, liens, rights, titles and interests pledged and granted to it under the ABL IP Security Agreement and the ABL Security Agreement with respect to all such Retained Collateral, and the Administrative Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Partial Release. Except as expressly modified hereby, the ABL IP Security Agreement and the ABL Security Agreement shall remain in full force and effect, each in accordance with the provisions thereof on the date thereof.

The Administrative Agent hereby authorizes the Borrower, the Grantors, the Purchaser and their successors, assigns or other legal representatives to make filings with the United States Patent and Trademark Office and other necessary filings, in each case at the expense of the Borrower, to evidence the release and termination of the Administrative Agent's security interests in the Released IP Collateral.

THIS PARTIAL RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE ADMINISTRATIVE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
