NOW, THEREFORE, in consideration of the covenants and promises set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:



Assignor hereby conveys, assigns, transfers and delivers absolutely to Assignee, its successors and assigns free from encumbrances, all rights, title and interests throughout the world in and to the Marks, together with the goodwill of the business connected with and symbolized by the Marks and all rights and powers arising or accrued therefrom including, without limitation, the right to sue and recover damages and other remedies for future and past infringements of the Marks and to fully and entirely stand in the place of Assignor in all matters related thereto.

2. Assignor agrees to take such further action and to execute such additional documents as may be necessary to perfect Assignee's title in and to the Marks.

3. This Intellectual Property Assignment shall be governed by and construed in accordance with the laws of the State of South Dakota without reference to its choice of law rules. The parties hereto, by mutual agreement in writing, may amend, modify and supplement this Intellectual Property Assignment. The failure of any party hereto to enforce at any time any provision of this Intellectual Property Assignment shall not be construed to be a waiver of such provision, nor in any way to affect the validity of this Intellectual Property Assignment or any part hereof or the right of any party thereafter to enforce each and every such provision. This Intellectual Property Assignment may be executed in one or more counterparts, each of which shall be considered an original instrument, but all of which shall be considered one and the same agreement.
