**TERMINATION AND RELEASE OF SECURITY INTEREST

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of April 25, 2019 (“Release”), is made by BMO Harris Bank N.A., a national banking association with an address at 50 South Sixth Street, Suite 1000, Minneapolis, Minnesota 55402 (“Secured Party”) in favor of Birchwood Casey, LLC, a Minnesota limited liability company (“Grantor”).

**WHEREAS**, pursuant to that certain Security Agreement dated as of April 29, 2016 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and between Grantor and Secured Party, Grantor granted to Secured Party a security interest in and to, among other things, certain intellectual property of Grantor (collectively, “Intellectual Property Collateral”); and

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to Secured Party the Intellectual Property Security Agreement for recording with national, federal and state government authorities including, but not limited to, the United States Patent and Trademark Office and the United States Copyright Office (the “IP Security Agreement”).

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or IP Security Agreement, as applicable.

**SECTION 2. Termination and Release.** Secured Party, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases Secured Party’s security interest in Obligor’s right, title, and interest in and to the Intellectual Property Collateral including, without limitation, the Patents and Patent Applications listed on **Schedule 1** attached hereto, the Trademark Registrations and Applications listed on **Schedule 2** hereto and the Copyright Registrations and Applications listed on **Schedule 3** hereto, in each case granted pursuant to the Security Agreement or IP Security Agreement; and

(b) authorizes the recordation of this Release with the United States Patent and Trademark Office and the United States Copyright Office at Obligor’s expense.


**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Minnesota.
