NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of July 8, 2019 is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Administrative Agent, with offices at 1525 West W.T. Harris Boulevard, MAC D1109-019, Charlotte, North Carolina 28262 (referred to herein as the "Administrative Agent"), in favor of JACK IN THE BOX INC., a Delaware corporation, having its chief executive office at 9330 Balboa Avenue, San Diego, CA 92123 (the "Grantor"), pursuant to that certain Second Amended and Restated Collateral Agreement, dated as of September 16, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among the Grantor, the Administrative Agent and other parties thereto.

W I T N E S S E T H:

WHEREAS, in connection with the Collateral Agreement, the Grantor executed and delivered the Notice of Grant of Security Interest in Trademarks, dated as of September 16, 2016 in favor of the Administrative Agent (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Administrative Agent for the ratable benefit of the Secured Parties a continuing security interest in and continuing lien upon the trademarks and trademark applications set forth on Schedule A attached hereto (collectively, the "Released Trademarks");

WHEREAS, the Administrative Agent recorded its security interest in the Released Trademarks with the United States Patent and Trademark Office (the "USPTO") on October 13, 2016, at Reel/Frame No. 5899/0054; and

WHEREAS, the Administrative Agent has duly authorized the execution, delivery and performance of this Release.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent agrees, for the benefit of the Grantor, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Release, including its preamble and recitals, have the meanings provided or provided by reference in the Collateral Agreement (it being understood that, in the event of any conflict, such terms shall have the meanings provided or provided by reference in the Collateral Agreement).

SECTION 2. Release of Security Interest. The Administrative Agent does hereby terminate, cancel and release its lien and security interest in, and right of setoff against, all of the Grantor's right, title and interest in, to and under each of the Released Trademarks, and the Administrative Agent hereby assigns to the Grantor any right, title or interest it may have in or to any of the Released Trademarks.

SECTION 3. Termination. The Administrative Agent, without any recourse, representation or warranty, hereby terminates and cancels the Trademark Security Agreement.

SECTION 4. Further Assurances. The Administrative Agent hereby authorizes the Grantor or the Grantor's authorized representative to (i) record this Release with the USPTO, and/or (ii) otherwise record or file this Release in the applicable governmental office or agency. The Administrative Agent further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request (at the Grantor's sole cost and expense) in order to confirm this Release and the Grantor's right, title and interest in, to and under the Released Trademarks.

SECTION 5. Choice of Law. This Release shall be governed by, and construed in accordance with, the laws of the state of New York, but giving effect to federal laws applicable to national banks.

SECTION 6. Counterparts. This Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
