NUNC PRO TUNC TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (this "Assignment"), is entered into *nunc pro tunc* effective as of September 26, 2018, by and between Euromarket Designs, Inc., an Illinois corporation with an address at 1250 Techny Road, Northbrook, Illinois 60062 ("Assignor"), and Design Foundry, LLC, a Delaware limited liability company with an address at 1105 22nd St SE, Hickory, NC 28602 ("Assignee").

WHEREAS, Assignor and Assignee entered that certain Limited Liability Company Agreement of Design Foundry, LLC dated September 26, 2018, which was amended pursuant to that certain Amended and Restated Limited Liability Company Agreement of Design Foundry, LLC dated January 1, 2019 (collectively, the "Agreements");

WHEREAS, Assignor is a Member of Assignee pursuant to the Agreements;

WHEREAS, Assignor is the owner of U.S. Trademark Application No. 88/036,566 for the mark DESIGN FOUNDRY, together with all common law rights therein as well as all goodwill associated therewith and symbolized thereby (collectively, the "Mark"); and

WHEREAS, Assignor desires to assign all of its right, title and interest in and to the Mark to Assignee as a Member contribution to the formation of Assignee, and Assignee wishes to acquire all right, title and interest in and to the Mark, including the portion of Assignor's business to which the Mark pertains.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor has sold, assigned, transferred and conveyed, and does hereby sell, assigns, transfers and conveys to Assignee all right, title and interest in and to the Mark, together with (i) all common law rights therein, (ii) the goodwill of the business connected with the use of and symbolized by the Mark, (iii) the portion of Assignor's business to which the Mark pertains, and (iv) the right to bring suit on and recover damages for any and all past, present, and future infringements of the Mark.
