**TERMINATION AND RELEASE
OF COLLATERAL ASSIGNMENT FOR SECURITY**

This Termination and Release of Collateral Assignment for Security ("**Termination and Release**") is hereby granted, conveyed and delivered as of the 18th day of June, 2019, by KNIGHT THERAPEUTICS INC., a Canadian corporation, having a principal address at 3400 de Maisonneuve W., Suite 1055, Montreal, Quebec H3Z 3B8 ("**Secured Party**"), in favor of MEDIMETRIKS PHARMACEUTICALS, INC., a Delaware corporation, having a principal address at 383 Route 46 West, Fairfield, NJ 07004 ("**Medimetriks**").

WHEREAS, pursuant to a certain Intellectual Property Security Agreement dated February 17, 2016 (the "**IP Security Agreement**"), Medimetriks granted to the Secured Party a security interest in and to all of its right, title and interest in and to certain trademarks and domain names, including the trademark registrations and applications and domain names listed on Schedule A annexed hereto (collectively, the "**Trademarks and Domain Names**"), together with all goodwill of the business symbolized thereby, and all proceeds with respect thereof, including without limitation, any and all causes of action, and all rights to recover any damages and other proceeds with respect thereto, which may exist by reason of infringement of the Trademarks (as further described in the IP Security Agreement) (collectively, the "**Collateral**") and recorded such security interest with the United States Patent and Trademark Office on February 18, 2016 at Reel 5734, Frame 0872;

WHEREAS, Medimetriks granted the Secured Party the foregoing security interest to secure Medimetriks's obligations (collectively, the "**Obligations**") under that certain Loan Agreement, dated as of February 16, 2016, as amended, between the Secured Party and Medimetriks, and other related loan documents dated on even date therewith (collectively, the "**Financing Agreements**");

WHEREAS, Medimetriks has fulfilled all of its outstanding Obligations to the Secured Party under the Financing Agreements and therefore, in accordance with the terms of the IP Security Agreement, the parties hereto desire to record this instrument to confirm and evidence the termination and release of the security interests held by the Secured Party in, to and under all Collateral, including the Trademarks and Domain Names.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Medimetriks and the Secured Party hereby acknowledge, the parties acknowledge and agree as follows:

1. Secured Party hereby unconditionally, irrevocably and absolutely terminates, releases, extinguishes and forever discharges the security interests it holds over the Collateral, including the Trademarks and Domain Names, and all renewals and extensions thereof, all income, damages and payments now and hereafter due or payable with respect thereto, including, without limitation, damages and payments for past, present or future infringements thereof, the right to sue for past, present and future infringement thereof, and all rights corresponding thereto, including all goodwill of the business connected with and symbolized by the Trademarks and Domain Names.


2. Secured Party further acknowledges, agrees and warrants that this Termination and Release shall be binding upon Secured Party's parent company, subsidiaries and other related entities, if any, and its and their respective successors, assigns and legal representatives.

3. Secured Party hereby authorizes Medimetriks to record on its behalf, and hereby authorizes and requests that the Commissioner of the United States Patent and Trademark

Office or his/her delegate record, this Termination and Release against each of the Trademarks and Domain Names.
