## TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "**Release**") is made as of July 9, 2019 ("**Effective Date**") by WESTERN ALLIANCE BANK, an Arizona corporation (as successor in interest to Bridge Bank, National Association and together with its successors and assigns, "**Lender**") in favor of HOTSCHEDULES HOLDINGS, INC., a Delaware corporation ("**Holdings**"), HOTSCHEDULES.COM, INC., a Texas corporation ("**HotSchedules**"), RBC INTERMEDIATE HOLDCO, LLC, a Delaware limited liability company ("**RBC**") and RED BOOK CONNECT, LLC, a Delaware limited liability company ("**Red Book Connect**," together with Holdings, HotSchedules and RBC, "**Grantors**").

**WHEREAS**, the Grantors and Lender entered into that certain Second Amended and Restated Loan and Security Agreement dated as of June 29, 2018 (as amended from time to time, the "**Loan Agreement**");

**WHEREAS**, pursuant to the Loan Agreement, (i) HotSchedules executed and delivered to Lender that certain Intellectual Property Security Agreement dated March 10, 2015 and recorded with the United States Patent and Trademark Office ("**USPTO**") on March 14, 2015 at Reel/Frame No. 5478/0024 ("**HotSchedules Intellectual Property Security Agreement**"), (ii) RBC executed and delivered to Lender that certain Intellectual Property Security Agreement dated March 10, 2015 and recorded with the USPTO on March 14, 2015 at Reel/Frame No. 5478/0036 and with the United States Copyright Office on March 25, 2015 at V9922 D889 ("**RBC Intellectual Property Security Agreement**"), and (iii) RBC recorded the RBC Intellectual Property Security Agreement with amended schedules with the USPTO on April 14, 2016 at Reel/Frame No. 5771/0577 and on October 19, 2016 at Reel/Frame No. 5905/0388 ("**Amended RBC Intellectual Property Security Agreements**" and collectively with the HotSchedules Intellectual Property Security Agreement and the RBC Intellectual Property Security Agreement, "**IP Security Agreements**") , pursuant to which Grantors granted to Lender a security interest in all right, title and interest of Grantors in its Intellectual Property Collateral (as defined in the Intellectual Property Security Agreements).

**WHEREAS**, Grantor has satisfied its outstanding indebtedness to Lender.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably terminates, cancels, releases and conveys all liens and security interests it has in and to the Intellectual Property Collateral to Grantors as of the Effective Date.

Lender represents and warrants that: (i) it has the full power and authority to execute this Release; and (ii) it has not assigned, transferred, restricted or otherwise encumbered any security interest it has against the Intellectual Property Collateral.

Lender shall take all further actions, and provide to Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.

IN WITNESS WHEREOF, Lender has caused this Release to be executed by its duly authorized representative as of the Effective Date.
