RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "*Release*") is made effective July 9, 2019, by ORIX GROWTH CAPITAL, LLC, a Delaware limited liability company (together with its successors and assigns, "*Lender*").

WHEREAS, HOTSCHEDULES HOLDINGS, INC., a Delaware corporation ("*Holdings*"), HOTSCHEDULES.COM, INC., a Texas corporation ("*HotSchedules*"), RED BOOK CONNECT, LLC, a Delaware limited liability company ("*Red Book Connect*" and together with Holdings and HotSchedules, "*Grantors*") and the Lender entered into that certain Loan and Security Agreement dated as of February 10, 2017 (as the same may be amended, modified or supplemented from time to time, the "*Loan Agreement*") ; all capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed thereto in the Loan Agreement; and

WHEREAS, pursuant to the Loan Agreement, the Grantors executed and delivered to the Lender that certain (i) Intellectual Property Security Agreement dated February 20, 2017 and recorded with the U.S. Patent and Trademark Office ("*USPTO*") on February 10, 2017 at Reel/Frame No. 5987/0711 (the "*Intellectual Property Security Agreement*"), (ii) Amended and Restated Intellectual Property Security Agreement dated June 29, 2018 and recorded with the USPTO on June 29, 2018 at Reel/Frame No. 6368/0949 (the "*A&R Intellectual Property Security Agreement*"), and (iii) Notice of Grant of Security Interest in Trademarks dated as of October 9, 2018 and recorded with the USPTO on October 11, 2018 at Reel/Frame No. 6454/0422 (the "*Grant of Security Interest*" and collectively with the Intellectual Property Security Agreement, the A&R Intellectual Property Security Agreement, the "*Intellectual Property Security Agreements*"), pursuant to which the Grantors granted and pledged to Lender a security interest in all of its right, title and interest in, to and under its Intellectual Property;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby irrevocably and forever releases and terminates its security interest in and to the Intellectual Property, including, without limitation, the intellectual property described in Schedules A, B, and C attached hereto.


