2. Article 1 of the Articles of Incorporation of the Corporation is amended to read as follows:

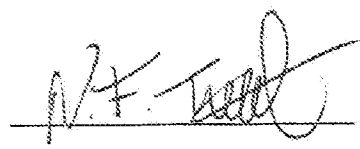
The name of this corporation is The Khronos Group Inc.
