**RELEASE OF TRADEMARK SECURITY INTEREST**

This Release of Trademark Security Interest (this "Release") is given on this 9th day of July, 2019, by JPMORGAN CHASE BANK, N.A. (the "Grantee"), to HOUCHENS NORTH FOODS, LLC (the "Grantor"), as follows:

WHEREAS, the Grantor, the Grantee and Houchens Food Group, Inc. entered into that certain Amended and Restated Trademark Security Agreement, dated as of September 28, 2012 (the "Trademark Security Agreement");

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Grantee, among other collateral as set forth therein, a continuing security interest in all of the Grantor's right, title and interest, including goodwill, in, to and under its United States trademarks, including but not limited to the trademarks listed on the attached Schedule A, together with all products and proceeds of such trademarks and all causes of action arising prior to or after the date thereof for infringement of such trademarks (the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent & Trademark Office on September 28, 2012, at reel/frame 4869/0580; and

WHEREAS, the Grantor has satisfied its obligations under the Trademark Security Agreement (including all conditions for release), and the Grantee wishes to release its security interest in the Trademarks, including those listed on Schedule A and retransfer and reassign to the Grantor without recourse all of the Grantee's right, title and interest in and to the Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby (i) terminates the Trademark Security Agreement and releases any security interest, right or other interest it may have in the Trademarks, including those listed on Schedule A, and hereby reassigns any and all right, title and interest it may have in and to the Trademarks without recourse to the Grantor, together with the goodwill of the business symbolized thereby and (ii) agrees to execute, acknowledge, procure and deliver to Grantor, at Grantor's expense, any and all further documents or instruments and do any and all further acts which the Grantor (or its respective agents, designees or assignees) reasonably request in order to confirm, effectuate or record this Release and Grantor's (or their assignees') right, title and interest in and to the Trademarks.
