Assignor further authorizes Assignee to apply for trademarks in foreign countries directly in its own name, and to claim priority of the filing date of the application for trademarks of the United States of America under the provisions of any and all international conventions and treaties.

Assignor hereby authorize and request the Commissioner of Patents and Trademark of the United States of America to issue and/or maintain trademarks upon the aforesaid application and division to Assignee, for the sole use and benefit of Assignee, its successors, assigns and legal representatives, to the full end of the term for which trademarks may be granted, the same as they would have been held and enjoyed by Assignor had this assignment not been made, and

we hereby authorize and request the equivalent authorities in foreign countries to issue and maintain the trademarks of their respective countries to Assignee.

We agree that, when requested, Assignor will, without charge to Assignee, but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining copyrights, patents, and trademarks for the inventions in any and all countries and for vesting title thereto in Assignee, its successors, assigns and legal representatives or nominees.

Assignor covenants with Assignee, its successors, assigns and legal representatives, that the interest and property hereby conveyed is free from all prior assignment, grant, mortgage, license or other encumbrance.
