**RELEASE OF SECURITY INTEREST IN

The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Lender may have obtained in and to the intellectual property under any agreement and any such right, title or interest of the Lender in any intellectual property of Grantor shall hereby cease and become void.

2. Further Assurances. The Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby.


