TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged: Assignor hereby assigns, transfers, and conveys to Assignee all rights, title and interest in and to the Trademarks, including the right to pursue actions for past infringement, together with the goodwill of the business in connection with which the Trademarks are used and which are symbolized by the Trademarks, and the Trademark Applications and Registrations relating thereto, as of the date this Assignment is signed by Assignor, the same to be held by Assignee as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made,. Assignor will cooperate with Assignee, including promptly executing any additional documents which might be requested by the Assignee to perfect, or otherwise give effect to, this Assignment and record Assignee as the owner of the Trademarks, or enable Assignee to seek registration of any of the Trademarks without further compensation by Assignor.




