Please be advised that (a) pursuant to the Security Agreement dated as of June 4, 2014 (as amended, modified, extended, restated, replaced, or supplemented from time to time, the “Security Agreement”), by and among the Obligor party thereto (each an “Obligor” and collectively, the “Obligors”) and Citizens Bank, N.A. (successor by merger to Citizens Bank of Pennsylvania), as Administrative Agent (the “Administrative Agent”) for the secured parties referenced therein (the “Secured Parties”), each of the undersigned Obligor has granted a continuing security interest in and continuing lien upon its right, title and interest in and to the trademark registrations and trademark applications shown on Schedule 1 attached hereto (the “Trademark Collateral”) to the Administrative Agent for the ratable benefit of the Secured Parties and (b) each of the undersigned hereby grants to the Administrative Agent, for the ratable benefit of the Secured Parties, a continuing security interest in its right, title and interest in and to the Trademark Collateral. Upon termination of such security interest, the Administrative Agent shall execute, acknowledge and deliver to the Obligor an instrument in writing in recordable form releasing the collateral pledge, grant, lien and security interest in the Trademark Collateral.
