TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is entered into as of July 15, 2019 by and between **OneDome Global, Inc.**, a California corporation ("**Assignor**"), and **Glo Big Boss Ltd.**, a Hong Kong corporation ("**Assignee**"), with reference to the following facts.

RECITAL

Assignor has agreed to assign all of its right, title and interest in and to the trademark described in **Exhibit A** attached hereto (the "Mark") subject to the terms and conditions set forth below.

AGREEMENT

1. In exchange for the payment of US\$5,000 (Five Thousand Dollars), Assignor hereby assigns, grants, conveys, transfers and sets over to Assignee all of Assignor's right, title and interest in and to the Mark, together with the goodwill of the business in connection with which the Mark has been used as of the date hereof. This includes, without limitation, the application for the Mark pending with the USPTO.
2. Within 24 hours after Assignor's execution of this Agreement, Assignee shall initiate an interbank transfer in the amount of US\$5,000 (Five Thousand Dollars), net of bank transfer fees, to the bank designated by Assignor, as payment in full for the rights transferred herein.
3. Assignee will have the right to submit this Agreement for recordation with the USPTO only after Assignor or its legal counsel has received payment of US\$5,000 (Five Thousand Dollars).
4. Upon request by Assignee, Assignor will provide all prior use information under its control, if any, that Assignee might need to overcome the outstanding rejection by the PTO based on insufficient specimens.
5. This Agreement: (a) may be modified only by a written instrument signed by both parties; (b) is the entire understanding of the parties with respect to the subject matter hereof; (c) shall be binding upon and inure to the benefit of each party; (d) shall confer no rights or remedies of any nature upon any other person or entity; (e) shall be governed by and construed in accordance with the laws of the State of California applicable to contracts made and performed in such State without regard to conflicts of law doctrines, except to the extent that certain matters are preempted by federal law.
