PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of July 16, 2019 (the “Release”) is made by Wells Fargo Bank, National Association, as administrative agent (the “Lienholder”).

WITNESSETH

WHEREAS, pursuant to the (i) Trademark Security Agreement, dated as of April 8, 2014 (the “2014 Trademark Agreement”), and recorded with the U.S. Patent and Trademark Office on April 14, 2014 at Reel/Frame 5259/0468, by and among Jasper Parent LLC, a Delaware limited liability company (“Jasper”), Nine West Holdings, Inc., a Delaware corporation (n/k/a Premier Brands Group Holdings LLC, a Delaware limited liability company) (“Premier Brands”), One Jeanswear Group, Inc., a New York corporation (n/k/a One Jeanswear Group LLC, a New York limited liability company) (“Jeanswear”), Nine West Development LLC, a Delaware limited liability company (n/k/a Premier Brands IP LLC) (“Development” and, together with Jasper, Premier Brands, and Jeanswear, the “2014 Grantors”), and Lienholder, (ii) the Trademark Security Agreement, dated as of March 2, 2015 (the “2015 Trademark Agreement”) and recorded with the U.S. Patent and Trademark Office on April 7, 2015 at Reel/Frame 5493/0726, by and between Development and Lienholder, (iii) the Trademark Security Agreement, dated as of April 28, 2017 (the “2017 Trademark Agreement”) and recorded with the U.S. Patent and Trademark Office on May 3, 2017, by and among Development, Jeanswear and Lienholder, (iv) the Trademark Security Agreement, dated as of April 11, 2018 (“2018 Trademark Agreement”), and recorded with the U.S. Patent and Trademark Office on April 16, 2018 at Reel/Frame No. 6340/0754, by and among Development, Jeanswear, Kasper Group LLC, a Delaware limited liability company (“Kasper” and, together with Jeanswear and Development, the “2018 Grantors”), and Lienholder, and (v) the Trademark Security Agreement, dated as of March 20, 2019 (the “2019 Trademark Agreement” and together with the 2014 Trademark Agreement, the 2015 Trademark Agreement, the 2017 Trademark Agreement and the 2018 Trademark Agreement, the “Trademark Agreements”), and recorded with the U.S. Patent and Trademark Office on 03/26/2019 at Reel/Frame No. 6601/0218, by and among Kasper, Jeanswear, and Development (collectively, the “2019 Grantors” and together with the 2014 Grantors and the 2018 Grantors, collectively the “Grantors”), and Lienholder, the Grantors have granted the Lienholder a lien on and continuing security interest in, all of their right, title and interest in, to and under the United States trademarks set forth on Schedule A attached hereto (collectively, the “Released Trademarks”);

WHEREAS, the Lienholder has agreed to release certain collateral in connection with a sale of certain assets by the Grantors;

NOW, THEREFORE, the Lienholder hereby:

1. releases any and all liens, security interests, right, title and interest of the Lienholder granted pursuant to the Trademark Agreements in the Released Trademarks without recourse or representation or warranty, express or implied, of any kind or nature whatsoever;


2. retains all of its liens and security interests in all collateral covered by the Trademark Agreements, other than the Released Trademarks; and

3. authorizes the Grantors to record this Release, along with any other necessary documentation, with the United States Patent and Trademark Office at the sole expense of the Grantors.



