**TERMINATION OF TRADEMARK SECURITY AGREEMENT  
AND  
RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this "Release"), dated as of July 17, 2019, is made by and among SunTrust Bank, a Georgia banking corporation, as Lender ("Lender"), in favor of ImaPizza, LLC, a Delaware limited liability company ("Borrower"), as follows:

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement, dated as of November 29, 2016 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on November 30, 2016 at Reel/Frame No. 005931/0420, Borrower granted Lender a lien on and security interest in Borrower's entire right, title and interest in, to and under the Collateral (as defined in the Security Agreement), including, without limitation, trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Borrower connected with and symbolized by such trademarks, including without limitation those set forth on Schedule A attached hereto (collectively, the "Trademarks");

WHEREAS, Borrower has paid all of its outstanding indebtedness to Lender; and

WHEREAS, Borrower has requested that Lender release its lien on and security interest in, all right, title and interest of Lender in and to the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender, without recourse, representation or warranty and at the Borrower's sole cost and expense, hereby terminates, cancels, reassigns to Borrower, and releases its lien on and continuing security interest in the Collateral, including the Trademarks, and all of the goodwill of the business of Borrower connected with the use of, and symbolized by the Trademarks, and any and right, title and interest of Lender in the Collateral, including the Trademarks, shall hereby terminate, cease and become void.

Lender authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.

Lender agrees to provide Borrower with any information and additional authorization and documentation necessary to effect the release of Lender's security interest in the Collateral (without recourse, representation or warranty and at Borrower's sole cost and expense).
