DigiCert, Inc., a corporation duly organized and existing under and by virtue of the laws of the State of Utah, desiring to merge GeoTrust LLC, a limited liability company duly organized and existing under and by virtue of the laws of the State of Delaware, with and into itself, pursuant to the provisions of Section 18-209 of the Limited Liability Company Act of the State of Delaware (the "Delaware Code"), DOES HEREBY CERTIFY as follows:

**FIRST:** The name and state of formation of each constituent entity of the merger (the "Merger") are as follows: (i) GeoTrust LLC, a Delaware limited liability company (the "Company") and (ii) DigiCert, Inc., a Utah corporation ("DigiCert").

**SECOND:** A Plan of Merger (the "Merger Agreement"), dated December 20, 2017 between the Company and DigiCert has been approved, adopted, certified, executed and acknowledged by each constituent entity, in accordance with the requirements of Section 18-209 of the Delaware Code.

**THIRD:** The name of the surviving corporation of the Merger is DigiCert, Inc., a Utah corporation (the "Surviving Corporation").

**FOURTH:** An executed copy of the Merger Agreement is on file at the office of the Surviving Corporation, 2801 North Thanksgiving Way, Suite 500, Lehi, Utah, 84043.

**FIFTH:** A copy of the Merger Agreement will be furnished by the Surviving Corporation, upon request and without cost, to any member of the constituent entities or any person holding an interest in any other business entity which is to merge or consolidate.

**SIXTH:** The merger, after filing the Certificate of Merger with the Delaware Secretary of State, shall be effective as of December 31, 2017.

**SEVENTH:** The Surviving Corporation agrees that it may be served with process in the State of Delaware in any action, suit or proceeding for the enforcement of any obligation of any domestic limited liability company which is to merge, irrevocably appointing the Secretary of

State as its agent to accept service of process in any such action, suit or proceeding and the address to which a copy of such process shall be mailed by the Secretary of State is 2801 North Thanksgiving Way, Suite 500, Lehi, Utah 84043.
