TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment"), dated as of April 30, 2019 ("Effective Date"), is by and between Weatherford Technology Holdings, LLC, a Delaware limited liability company ("Assignor"), and Stratum Reservoir (US), LLC, a Delaware limited liability company ("Assignee").

Assignor shall, at Assignee's or its successors' or assigns' sole expense, provide Assignee, its successors and assigns with all such assistance as it may reasonably request for the full utilization of the rights granted above, including upon request by Assignee to execute all applications and any further assignments or other documents or instruments, sign all lawful papers, and make all rightful oaths necessary or desirable to carry out the purposes or intent of this Assignment and to aid Assignee or its successors, assigns or other legal representatives to obtain and enforce proper protection for the Trademark in all jurisdictions and to record Assignee as owner of the Trademark, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.


This Assignment shall be governed by and construed in accordance with the laws of the State of Texas without giving effect to any choice or conflict of law provision or rule (whether of the State of Texas or any other jurisdiction).
